
1 APRIL 2023 QUARTERLY REPORT

The Australian Government Organisations Register provides information on the function, composition, origins and other details of Australian Government bodies.

The dataset is updated continuously and the following statistics reflect the dataset as at 1 April 2023. The statistics are updated on a quarterly basis. The total number of bodies reported by the Register as at 1 April 2023 is 1,300.

24 bodies that were ceased by the Government have been removed from the Register, 22 bodies added to the Register, and 2 bodies were reclassified since the last update as at 1 April 2023.
