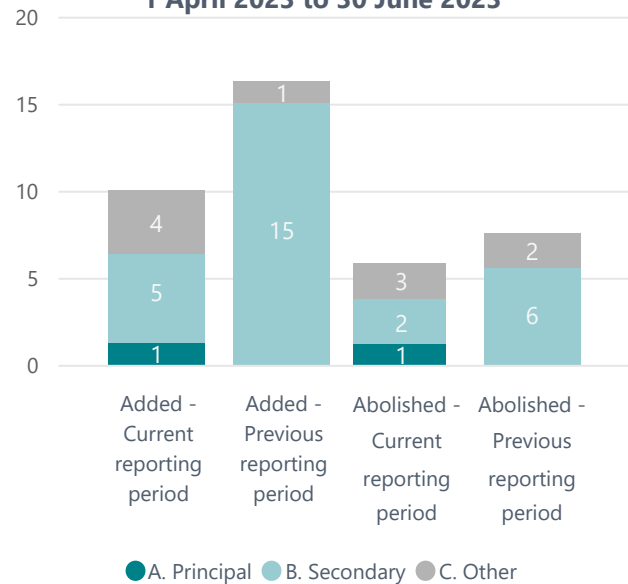
30 JUNE 2023 QUARTERLY REPORT

The Australian Government Organisations Register provides information on the function, composition, origins and other details of Australian Government bodies.

The dataset is updated continuously and the following statistics reflect the dataset as at **30 June 2023**. The statistics are updated on a quarterly basis. The total number of bodies reported by the Register as at **30 June 2023** is **1,312**.

14 bodies that were ceased by the Government have been removed from the Register and **26** bodies added to the Register since the last update as at **1 April 2023**

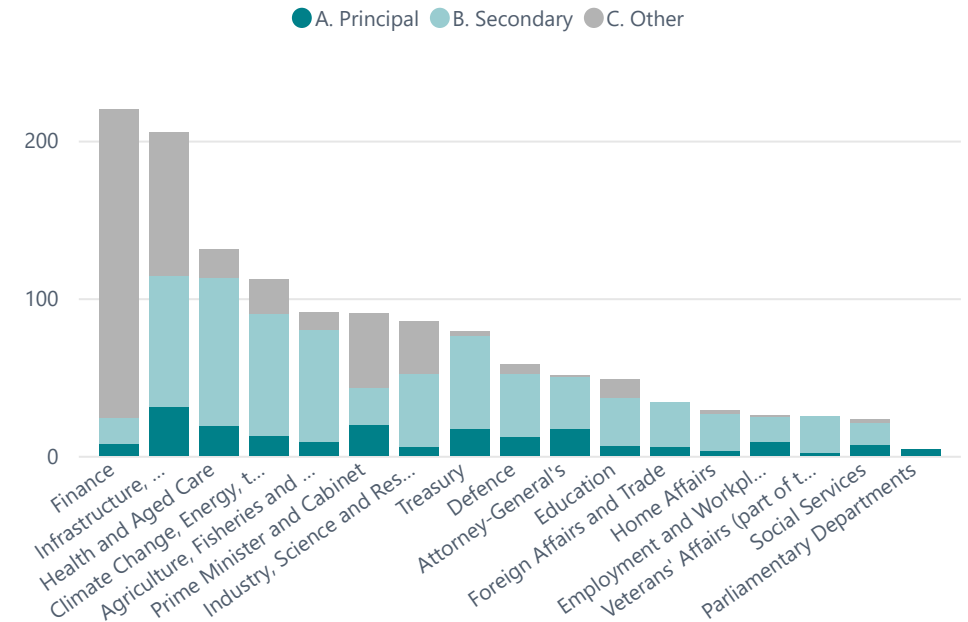
